安全标识符号

在本操作手册和该产品上,利用了一些安全标识符号和专业词汇来表达重要的安全注意事项和安全规范。 本节内容主要是帮助读者能更好地理解这些标识符号和用语。

A

这是安全警告符号-用于对一些潜在的人身伤害危险进行警示。

必须遵守安全信息的指导来规避可能的伤害事故发生,甚至死亡。

⚠ 6 险 危险警告符号-表示一些存在危险情况的环境,如果不能避免,将导致死亡和严重的伤害事故。

▲ 警告 警告符号-表示危险的境况,如果不能避免,也可能导致死亡或严重的伤害事故。

▲ 小心 小心符号-表示危险的境况,如果不能避免,可能导致轻微或中等程度伤害事故。

基本安全规范

▲ 警告

电动工具的涵义是指带有电源线直接由外部电源提供电力和不 带电源线由电池提供电力的两类设备。

工作区域安全

- 保持工作场所干净整洁和照明充分。混乱和昏暗的环 境容易引起安全事故的发生。
- 不要在易燃易爆等的危险环境下操作机器,例如易燃 易爆的液体、气体或粉尘环境下。电动工具易产生火 花,会引燃这些粉尘或气体。
- 在操作机器时,使无关人员(包括小孩、旁观者、非工作人员等)远离工作现场。注意力分散容易导致安全事故的发生。

电气安全

- 电动工具插头应该和插座相匹配。任何时候都不要改变插头。不要与连接有接地电动工具的适配器插头一起使用。不改变插头并与插座相匹配将会降低电击事故的发生率。
- 避免身体与接地物体的表面接触,如金属管道、散热器、 金属柜体和制冷设备。如果身体和接地物体接触将增加 触电事故的发生率。
- **不要把电动工具放置雨中或潮湿的环境下**。水进入电动工具将增加触电事故的发生率。
- 不要损坏电源线。不要把电源线用来拖拽电动工具。使电源线远离高温、油、尖锐边缘或移动物体。电源线损坏或卷入其它物体中都会增加电击事故的发生率。
- **当在室外使用电动工具时,请使用适合在室外工作的接 线板**。这样能降低电击事故的发生率。
- 避免在潮湿的环境下使用电动工具,请使用接地故障断 续电路(GFCI)保护装置。使用GFCI可以降低电击事 故的发生率。

个人安全

- 使用电动工具时,保持头脑清醒,关注自己手头的工作。不要在疲惫或受到药物、酒精或毒品影响的情况下使用电动工具。如果在使用当中稍不留神,就会导致比较严重的伤害事故的发生。
- 使用个人防护用品,始终佩戴安全眼镜。个人防护用品包括防尘面罩、防滑安全保护鞋、安全帽或听力防护装置。适当使用这些防护用品,将减少人身伤害事故的发生。
- 不要无意识开机。在接通电源和/或装上电池或是拿起或携带工具前,确保开关置于关闭状态。当你携带电动工具,手指不小心触动开关或在开关置于开机状态时接通电动工具都会导致安全事故的发生。
- 开机前拿走所有调节工具,如扳手、钳子等。如果这些工具处在旋转部件上,将会导致人身伤害。
- 保持身体平衡,不要在操作机器时使身体失去平衡。 这样会使你在意外情况下更好的控制工具。
- 正确着装。不要穿宽松的衣服或佩戴首饰。让你的衣服、头发和手套远离活动部件。宽松的衣服、首饰和长发容易卷入活动部件中。
- 如果工具用于粉尘收集装置的连接,请确保使用方法 正确,从而减少与粉尘相关的事故。

电动工具的使用与维护

- 不要过度使用电动工具,请在不同场合选择合适的电动工具。合适的工具将会使你更快、更安全地完成作业。
- •如果开关不能工作,请不要使用电动工具。任何 电动工具如果不能控制开关,都是非常危险的并 且必须立即进行修理。
- 在对工具进行调整、更换附件、存放前必须先断 开电源或者把电池取下来。这些措施可以预防意 外接通工具的风险。

- 存放电动工具时注意不要让无关人员能够拿到,尤其 是小孩。因为电动工具对于未经过培训的人员来说是 非常危险的。
- 维护工具。检查是否活动部件的位置不正确、零件有损 坏或其他可能影响工具正常使用的损坏状况,如果有, 请在使用前务必修理好。许多事故的发生都是由于工具 的维护不当造成的。
- 确保切割部件锋利清洁,这样工作时不易粘结,易于控制。
- 按照操作指南、工作环境要求和工作目的来正确使用 电动工具及其附件和其它组件。如果工具与工作环境 和目的不匹配,可能会导致危险的发生。

电池工具的使用和维护

- 请选择操作手册里指定的充电器对电池进行充电。适合某一特定类型电池的充电器如果用于其它类型的电池充电可能会引发火灾。
- 电动工具只可使用专用电池。使用任何其它类型电池 可能导致人身伤害或火灾。
- 电池不使用时,使其远离金属物体,如回形针、硬币、 钥匙、钉子、螺丝或其它小型的可能连接两极的金属 物体。同时将电池两极短路可能导致灼伤或起火。
- 如果环境恶劣,电池的液体可能会溢出;不要接触电池液体。如果意外碰到,请用水冲洗。如果液体接触到眼睛,请就医。从电池中溢出的液体可能导致刺激或灼伤。

售后服务

• 请让经过培训合格的维修人员进行产品维修服务,并 选择经过认证的合格零部件。这样可以确保工具的使 用安全和保养正确。

压接工具安全使用规范

- 请使用RP 218压接工具的RIDGID®型压接附件(如压 接钳、压接环、转换压接钳等)。 将RP 218压接工具用于其它用途可能损坏本工具和附 件, 甚至导致人身伤害。
- 压接过程中,请确保手指和手远离压接附件。否则压 接钳或部件可能压伤手指和手、甚至导致骨折和切断。
- 永远不要试图维修损坏的压接钳、压接环、或其它部 件。如果对这些附件进行焊接、打磨、钻孔或其它改 变, 在压接时会引起严重安全事故。报废损坏的压接 钳,需要用新的进行更换。除了损坏的压接钳复位弹 簧, 切勿更换其他零件。详情请致电艾默生精密工具 技术(上海)有限公司技术服务部门。

产品概述、规格和标准设备

概述

RP 218压接工具和相应的标准压接钳配合使用,通过机 械力施加于管件上形成不透水的永久密封。当按下RP 218 的开关后,一个内置的电机会驱动液体进入工具的油缸, 让凸轮向前运动并产生数千磅的压力施加于特殊设计的 管件上。附件也可供其它用途使用。

整个压接过程大约持续3.5秒。当开始压接管件时,松开 扳机,工具会立即停止,再次按下扳机,工具会自动继 续工作直到完成整个过程。工具尾部的LCD显示了不同 的故障类型,如温度不正确、电池电量低或者需要维护 保养等。

RP 218带有两(2)个织物环,可用于装配肩带或扎绳。

标准设备

RP 218如与电池一同订购。则提供的是2.5Ah的电池。 5.0Ah电池可作为附件提供(见第10页)。更高安培数 的电池每次充电可进行更多次的压接,但重量更重。

注意! RIDGID提供两种系列的压接钳和附件:

- 标准系列
- 紧凑型系列

这两个系列不能互换, 即标准系列压接钳仅适用 于标准系列的压接工具,如(RP310 PLUS, RP 318, RP 330, RP 340, CT-400)。同样, 紧凑型系列压接钳仅适用干紧凑型系列的压接工具. 如(紧凑型100-B,RP 200-B, RP 210-B,RP 218)。

注意 管道材料的选择和接头的形式有该系统的设 计人员和/或安装人员来负责。在安装前,应仔细权衡管 道的使用环境,包括化学因素和温度条件。请咨询管道 压接系统供应商来获得相关的选择信息。

工具完好性检查



在每天使用压接工具前,请仔细检查工具和校正发现的 问题,以减少电击、机械损伤、附件失效和其它原因引 起的各种伤害事故发生的风险,并保护工具免受损坏。

▲ 警告

- 1. 确保检查工具前已取下电池。检查电池是否完好。如 果发现有任何不妥的地方, 不要继续使用工具并立即 讲行修理。
- 2. 清除任何油脂、灰尘, 尤其是手柄和控制元件上面。 这样可以防止使用过程中工具发生滑脱。
- 3. 按照下列事项检查工具:
 - 装配适当, 正确维护, 产品完整。
 - 是否有任何破损, 磨损, 丢失, 或结合部分错位。
 - 确保附件安装销可以顺利全开和全闭(图3和4)。
- 确认开关自如,不卡或粘连。

- 警告标识存在和可读(图2)。
- 检查织物的循环是完好无损的, 缝合不破。
- 任何其他影响安全和正常运行的情况。
- 如果发现有任何问题,不要使用压接工具直到问 题被修复。
- 4. 按照操作手册要求检查和保养工具、各种附件、电 池及充电器。

- 5. 保持操作时手掌干燥, 装入充满电的电池。按一下红 色按钮,打开压接工具。LED灯会亮起并一直亮着表 示工具处于就绪状态。如果有其它情况, 请根据故障 诊断代码(第12页)来确定下一步行动,在工具恢复 正常前不要使用。让手指和手远离凸轮,测试机器是 否可以正确操作。当使用附件时,如果负载足够大, 工具将会自锁以确保一个完整的压接过程能够完成。
- 6. 操作检查完毕后,用干燥的手取下电池。

工具组装和工作区域检查

▲ 警告





参照以下程序来组装工具和清理工作现场,可以减少电击、火灾、机械损伤或其他原因引起的伤害事故的发生,同时保护工具和管道系统完好。

- 1. 从以下几个方面检查工作区域:
- 照明充分
- 可燃液体、气体或粉尘容易引起燃烧。请不要在这些环境下使用工具,直到确认并进行整改。压接工具没有防爆保护措施,因此会产生火花。
- 在清洁、干燥、稳定的环境下操作。不要站在水中使用工具。
- 2. 检查所要进行的工作,根据应用场合来选择合适的 RIDGID工具及附件。如果附件使用错误,也会引起 伤害事故和工具损坏及管道连接不符合密封要求的 情况。如需完整的RIDGID电动压接工具附件清单,请访问www.RIDGID.cn网站查询产品目录或致电 艾默生精密工具技术(上海)有限公司客户服务热线 400-820-5695咨询。确保已根据工具和附件的使用 说明来对其进行检查。
- 3. 权衡工作区域看是否需要进行隔离,使旁观者远离工作地点,因为旁观者会使操作者注意力分散。
- 4. 确保已取下电池, 然后解锁并完全打开附件安装销 (见图3和图4)。如果工具中已有附件,则将其取下。
- 5. 装入正确的附件,然后完全闭合附件安装销,并旋转 到锁定位置,如图3。**附件安装销必须完全闭合并锁 紧,以防止工具在使用过程中被损坏**。

操作指南

▲ 警告





始终佩戴安全防护镜来保护眼睛免受粉尘或其它异物的伤害。

在压接循环过程中,保持手指和手远离附件。否则手指和手可能被工具或附件、工件和其它物件压伤甚至导致骨折或切断。

按照操作指南进行操作,减少受伤和工具被损坏的风险。

注意 以下操作指南部分适用于几种类型的压接工具附件的使用。严格遵守关于压接工具附件的特别使用规范和管件生产厂家的安装指导规范。否则,会使管道安装不正确而产生泄漏,从而导致财产损失。

压接前的准备工作

- 1. 确保工作区域没有闲杂人员和分散注意力的因素影响,且工具正确组装,工作场所符合工作要求。
- 2. 按照管件生产厂家的要求进行管道连接。

使用典型的剪式压接钳对管件进行压接

- 1. 确保RP 218安装了正确的压接钳,且安装销完全闭合且锁紧。 (见"工具组装和工作区域检查"章节)
- 2. 将充满电的电池装入手柄中。
- 3. 按下压接钳臂以打开压接钳(图5)。
- 4. 将打开的压接钳卡在管件周围(图6)。确保按照管件厂商的使用手册,将压接钳完全对准管件。不要让工具和压接钳直接悬挂在管件上,以避免工具不慎跌落造成不必要的伤害或死亡事故。
- 5. 确保遵循相应管件系统说明中的要求(即管道插入 管件的深度符合要求)。




图7 RP 218压接工具与管道垂直

- 6. 确保压接钳和工具与管道垂直(图7),如果压接钳和工具未与管道垂直,则在压接过程中工具会自己尝试对齐。这样就会导致压接不当或工具损坏。
- 7. 按下并松开开关,让工具接通。工具前部的LED灯会 一直点亮,表明工具随时可用。

注意!如果150秒钟不对工具进行操作,它将自动关闭。 要打开工具,需要再次按下开关。

按下工具的扳机(图1)。让手和手指远离压接钳,以避免被压伤。压接循环大约为3.5秒。一旦一次压接循环开始,且滚轴碰到压接钳臂时,工具会锁定并自动完成压接循环。当开始压接管件时,松开扳机,工具会立即停止,再次按下扳机,工具会自动继续工作直到完成整个过程。这样能确保压接管件的一致性、完整性和可重复性。

注意 如果电池电量太低而不能完成一个压接循环操作,则RP 218压接工具会自动关机。此时,LED灯不断闪烁进行提示。重新装上充满电的电池重复以上的操作过程。

如果压接过程中电池没电或工具发生故障,此时要使滚轴复位或从管道上取下工具,就必须按下泄压按钮(图1)。如果发生此类情况,则需要对连接处再进行一次压接以确保压接完整。

- 8. 压接循环完成后,按下压接钳臂打开压接钳。
- 9. 从管道上取下RP 218和压接钳,检查压接情况。 小心压接过程中可能产生的锋利边角。

检查压接情况

1. 检查压接后的管件。如果管件上有厂家附带的控制环和/或控制标签,则将其取下。厂家提供这些标示是为了表示这些管件还没有被压接过,去掉这些标示就说明这些管件已经被压接过了。

检查以下几个方面:

- 管件与管道错位严重。注意:压接后有稍许错位被视为正常。
- 管道插入管件的长度不够 再次检查管道上正确的插入长度标记是否和管件端部吻合。
- 压接钳或压接环没有和管件对齐,管件变形。按照 管件厂家的标准来检查是否有其它问题。
- 如果发现其它问题,则应拆下有问题的部分,换上一个新的管件和管道进行压接操作。
- 2. 按照正常操作和所在地的标准来测试系统。
- 3. 对于其它特殊检测标准,请参看压接系统操作手册。

维护指南

▲ 警告

在维护和调整工具之前,确保已取下电池。

清洁和润滑

- 1. 每天用干净的布擦拭工具。
- 2. 检查工具的附件安装销,必要时用硅润滑剂对销进行润滑。
- 3. 每次使用后检查附件中的复位弹簧。附件应只需手指稍许用力就能自由打开和关闭。

需要RIDGID授权维修中心提供的维修服务

在30000次工作循环后,只要工具开机, LED灯就会闪烁,这表明需要进行维护保养和校正机器。 LED灯闪烁后,如果不进行维护保养还继续工作循环2000次(共32000次),工具将自动停机。

维护保养服务为有偿付费项目。

▲ 警告

仅下所列附件可与RP 218压接工具一同使用。对于应配合其它相应工具使用的其它附件,如果用于本机器则会导致机器损坏。为了防止意外发生,请使用为RP 218专门设计的附件或推荐使用的附件。具体见下表。

将电池从工具上取下,并将其与工具一起存放在手提箱内。不要存放在过热或过冷的地方。当油温不在15°F(-10°C)到122°F(50°C)范围内时,工具的温度传感器不会允许工具启动。因此在使用前必须使工具处于操作规范所规定的温度范围内。工具前部的红色LED灯会以持续的闪烁两次然后停顿的方式作为提醒。

▲ 警告 工具要存放在干燥、安全、能够上锁的地方,避免儿童、无关人员能够取到。未经过培训的人员使用本工具将十分危险。

维修与服务

▲ 警告

不正确的维修与服务会使工具处于不安全的工作条件。

- 电动液压管道压接工具(RP 218),保证期为一年。
- 上述产品保证期限均自购买之日起开始计算(以经销商 开具的原始有效销售发票为准)。

非保证范围

由于不遵守操作说明、不正确使用、异常的环境条件、 不适当的操作条件、使用非原装附件、部件或零件所造成的损坏,以及易损件(诸如刀片、模头、液压密封圈、 液压油和充电电池等)等情况不在本保证之内。艾默生 精密工具技术(上海)有限公司不承担任何非产品缺陷 所致损失。

维修服务

经艾默生精密工具技术(上海)有限公司专业鉴定,用户就保证范围内产品享有维修服务:

- 在保证期内,对属于物料瑕疵或生产工艺缺陷的产品 予以免费维修;如果产品在保证期内经过三次维修后 仍无法正常使用,则予以更换相同或同类产品(同类 产品如有价差,多退少补)。

Description, Specifications And Standard Equipment Description

The RP 218 Press Tool, when used with appr-opriate RIDGID standard pressing attchments, is designed to mechanically press fittings onto tubing to create a watertight and permanent seal. When the switch on the RP 218 is depressed, an internal electric motor powers a hydraulic pump which forces fluid into the cylinder of the tool, forcing the ram forward and applying thousands of pounds of pressing force onto specially designed fittings. Attachments are also available for other uses.

The entire cycle duration is approximately 3.5 sec-onds. Once the cycle begins to deform a fitting, press the red switch to start the tool until completion. Release the switch the cycle will be stopped. The LCD screen on the back of the tool will blink to indicate issues such as improper temperature, low battery, or maintenance required.

The RP 218 comes with two (2) fabric loops that can be used with appropriate attachments such as shoulder straps or tie off lines.




Figure 2 - LCD Screen

Standard Equipment

The RP 218, if ordered with batteries, comes with 2.5Ah batteries. 5.0 batteries are available as acce-ssories (See Page 24). Higher amp hour batteries allow more press connections per charge, but also weigh more.

NOTE! RIDGID jaws and attachments are offered in two "series".

- Standard Series
- Compact Series

These series are not interchangeable. Only standard series jaws will work with standard series tools (RP310 PLUS, RP318,RP 330, RP 340, CT-400). Similarly,only compact series jaws will work with the compactseries tools (Compact 100-B, RP 200-B, RP 210-B, RP 218,).

Tool Inspection

A WARNING





Daily before use, inspect your press tool and correct any problems to reduce the risk of serious injury from electric shock, crushing injures, attachment failure and other causes, and prevent tool damage.

- Make sure that the press tool battery is removed. Inspect the battery for damage. If any damage or modifications are found, do not use until the battery has been properly repaired or replaced.
- 2. Clean any oil, grease or dirt from the equipment, especially the handles and controls. This helps to prevent the machine or controls from slipping from your grip.
- 3. Inspect the press tool for the following:
 - Proper assembly, maintenance and completeness.
- Any broken, worn, missing, misaligned or binding parts.

- Make sure that the attachment mounting pin moves smoothly between the fully open and fully closed positions (Figure 3 and 4).
- Confirm that the switch moves freely and does not bind or stick.
- Presence and readability of the warning symbol (Figure 2).
- Check that the fabric loops are undamaged and that the stitching is not torn.
- any other condition which may prevent safe and normal operation.

If any problems are found, do not use the press tool until the problems have been repaired.

4. Inspect and maintain the tool attachments, battery and charger as directed in their instructions.

- 5. With dry hands, insert a fully charged battery. Press the red switch one time in order to turn the press tool ON. The LED light should turn ON and remain on to indicate that the tool is ready for use. If any other conditions exist, use the Diagnostic Codes information (Figure 12) to determine the next step and do not use the tool until it is working properly. With your hands and fingers away from the tool ram, test the operation of the switch to confirm proper operation. When used with an attachment, once the tool sees enough load it will lock on to insure that a complete press is made.
- 6. Once the operation has been checked, with dry hands remove the battery.

Tool And Work Area Set-Up

A WARNING





Set up the press tool and work area according to these procedures to reduce the risk of injury from electric shock, fire, crushing injuries and other causes, and prevent tool and system damage.

- 1. Check work area for:
 - · Adequate lighting.
- Flammable liquids, vapors or dust that may ignite. If present, do not work in area until sources have been identified and corrected. The press tool is not explosion proof and can cause sparks.
- Clear, level, stable and dry place for operator. Do not use the machine while standing in water.
- 2. Inspect the work to be done and determine the correct RIDGID tool and attachment(s) for the application. Using an incorrect attachment for an application can cause injury, damage the tool and make incomplete connections. For a complete listing of RIDGID attachments available for this tool, see the Ridge Tool Catalog on line at www.RIDGID.cn or call Ridge Tool Customer Services 400-820-5695. Make sure that the tool and attachment have been inspected as directed in their instructions.
- 3. Evaluate the work area and determine if any barriers are needed to keep bystanders out. Bystanders can distract the tool operator during use.
- 4. Confirm that the battery is removed then unlock and fully open the attachment mounting pin. See Figure 3 and Figure 4. If there is an attachment in the tool, slide it out of the tool.
- 5. Slide the correct attachment in the press tool then fully close the attachment mounting pin and rotate into the locked position as shown in Figure 3. The attachment mounting pin must be fully closed and locked to prevent tool damage during use.

Operating Instructions

A WARNING





Always wear eye protection to protect your eyes against dirt and other foreign objects.

Keep your fingers and hands away from the tool attachment during the press cycle. Your fingers or hands can be crushed, fractured or amputated in the attachment or tool or between the attachment, work piece and other objects.

Follow operating instructions to reduce the risk of injury from crushing and other causes and to prevent tool damage.

NOTICE These instructions are generalized practices for several types of press tool attachments. Always follow the specific instructions for the press tool attachment

being used and the fitting manufacturers specific installation instructions. Failure to follow the specific attachment and fitting installation instructions may result in improper press connections that can lead to extensive property

Preparing The Connection

- 1. Make sure that the work area is free of bystanders and other distractions and that the tool and work area has been properly set up.
- 2. Prepare the connection according to the fitting manufacturers instructions.

Pressing A Fitting With Typical Scissor Jaws

- 1. Make sure the RP 218 Press Tool has the correct jaw installed and the mounting pin is fully closed and locked. (See Tool And Work Area Set Up Section.)
- 2. Insert fully charged battery into the base of the handle.
- 3. Squeeze jaw arms to open the jaws (Figure 5).
- 4. Place open jaws around the fitting (Figure 6). Make sure the contour of the jaws is properly aligned with the contour of the fitting as specified in Fitting Systems operator's manual. Do not attempt to hang the jaws and tool from fitting. Tool could unexpectedly drop and cause serious injury or death.
- 5. Make sure the tubing is inserted to the proper depth in fitting, as specified in the appropriate fitting system's instructions.

- 6. Make sure the jaws and tool are square to the tubing. (Figure 7) If the jaw and tool are not square to the tube, they will try to align as the press is made. This could cause an improperly pressed fitting or damage
- 7. Depress and release the switch one time to turn tool ON. The LED light on the front of the tool should be solidly illuminated indicating the tool is ready to press.

NOTE! Tool will automatically turn OFF if left unused for 150 seconds. To turn tool ON, it is necessary to once again depress the switch.

Depress the tool trigger switch (Figure 1). Keep fingers and hands away from the jaws to avoid crushing injuries in jaws and between jaws and surroundings. The press cycle takes about 3.5 seconds. Once a press cycle begins and the rollers contact the jaw arms. the tool will lock-on and automatically com-plete the press cycle. Releasing the trigger will stop the tool once the pressing process has begun. Pressing the switch again, tool will continue until completion. This assures consistent, repeatable press joint integrity.



NOTICE The RP 218 Press Tool will turn off automatically if the battery is too low to successfully complete a pressed connection. This will be indicated by a continuous ON/OFF flashing of the LED light. A fully charged battery should be inserted in the tool and the pressed connection should be repeated as indicated above.

To retract the rollers and remove the tool from the fitting if battery dies or tool malfunctions during pressed connection. If it is necessary to retract the rollers to remove the tool from the fitting, press the pressure release button (Figure 1). If this happens, the connection will need to be pressed again to insure completion.

- 8. After the cycle is complete, squeeze jaw arms to open the jaws.
- 9. Remove the RP 218 and jaws from tube and inspect the pressed connection. Avoid sharp edges that may have formed on the fitting during the pressing operation.

Inspecting The Pressed Connection

1. Inspect the pressed fitting. If the fitting is supplied with a control ring and/or a control label by the fitting manufacturer, remove it. Control rings and labels are supplied by the manufacturer to indicate that the fitting has not yet been pressed. Removal of the control ring and label indicates to others that the connection has been pressed.

Look for the following:

- Excessive misalignment of the tubes. Note that a slight amount of misalignment at the pressed connection is considered normal.
- Tubes that are not fully inserted into the fitting double check the insertion marks made on the tube to see that they are still aligned with the end of the fitting.
- Incorrect jaw or ring alignment with the fitting contour, distorted or deformed fitting.
- Any other issues per the fitting manufacturer. If any of these problems are found, then removal of the fitting is required and a new fitting and tube will need to be prepared and pressed in its place.
- 2. Test system in accordance with normal practice and local codes.
- 3. See fitting system's operator's manual for specific inspection criteria.

Maintenance Instructions

A WARNING

Make sure battery is removed from tool before performing maintenance or making any adjustment.

Cleaning And Lubrication

- 1. Wipe the tool clean daily with a clean dry cloth.
- 2. Inspect the attachment mounting pin and lubricate the pin with silicone lubricant as needed.
- 3. Check return springs in attachments with each use. Attachments should open and close freely with only moderate finger effort required.

Required Maintenance At RIDGID Authorized Service Center

After 30,000 cycles, the LED light will flash three times then pause continuously, to indicate that it is time for maintenance and recalibration. The tool will not run if it is not serviced within 2,000 cycles (32,000 total) after the first flashing LED.

Maintenance service is chargeable.



Storage

Remove battery from tool and store tool and battery in case. Avoid storing the tool, batteries or charger in extreme heat or cold. The tool temperature sensor will not allow the tool to turn on if oil temperature is not within the temperature range of 15°F (-10°C) to 122°F (50°C). So it may be necessary to allow the tool to warm or cool to a temperature within the operating range by placing it in a



conditioned room before use. This will be indicated by two flashes and a pause continuously, of the LED light on the front of the tool.
